# ULTRASHORT LATIN AMERICA PROFUND

## Fund objective

UltraShort Latin America ProFund seeks daily investment results, before fees and expenses, that correspond to two times the inverse (-2x) of the daily performance of the S&P Latin America 35 ADR (the "Index")<sup>SM</sup> Index (USD). The Fund does not seek to achieve its stated investment objective over a period of time greater than a single day.

The UltraShort Latin America ProFund seeks daily investment results, before fees and expenses, that are -2x the return of the S&P Latin America 35 ADR Index (the "Index") for a single day, not for any other period.

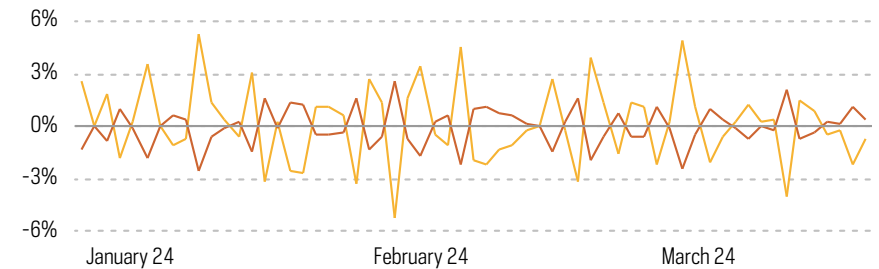



